**TAX LEVY ORDINANCE**

**TOWNSHIP**

**ORDINANCE NO. 2015-4**

An ordinance levying taxes for all town purposes for Lockport Township, Will County, Illinois, for the tax year 2015, collectable in calendar year 2016.

BE IT ORDAINED by the Board of Trustees of Lockport Township, Will County, Illinois as follows:

SECTION 1: That the sum of one million eight hundred eighty thousand three hundred fifty-nine and no/100 Dollars (\$1,880,359) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
